\*\*Please note that the entry deadline for your region is **60 days prior to the contest date.**

- *If you register for competition after the entry (60 day) deadline, you will have an additional \$100 fee added onto your registration.*
- *As well as the late fee, your chorus/quartet will not be entered into the initial draw for order of appearance, drawn 55 days prior to competition, but rather in a secondary draw two weeks later (after the late entry deadline).*

**No entries will be accepted after the late entry (45 day) deadline - no exceptions!**

Remember: Only chorus presidents/team coordinators, directors, or treasurers can register a chorus (or prospective chorus) for competition, and only the quartet contact can register a quartet.
